Membership Form

The Membership Form is an offer by you/your group to become a member of Connect, subject to these T&Cs. Your Membership Form is only accepted when we process your payment and confirm acceptance in writing to you, at which point your Connect Membership will begin. Membership Form refers to both printed and online membership forms.

Connect Parent Council/PTA and Clubs/Organisations Memberships: Your Membership Form must identify an active committee member of your organisation authorised to act on your behalf to be responsible for your Connect Membership (the Key Contact) and must provide valid contact information (including an email address and phone number) for the Key Contact. The email address should preferably be the generic email address of your parent group. You must appoint a new Key Contact if the existing one is no longer an active committee member.

You must let us know about the change of Key Contact (via the online <u>Members Portal</u>, by emailing <u>info@connect.scot</u> or any other means we may advise you about).

As part of Connect Membership insurance cover, if your group is an employer, **you must provide your Employer Reference Number (ERN)** to comply with government regulations. ERN numbers are printed on mandatory documents including P45, P60, P11/D and payslips. You may be exempt from this process if your PAYE threshold is below £503.00 per month.

Individual Membership: You must provide contact information (including an email address and phone number).

You must ensure that the information you provide to us (including the details on the Membership Form) is correct (and inform us if any information changes) and co-operate with us in all matters relating to your Membership.

Fees and renewal

Your Membership fee is set out on the Membership Form and is payable annually in advance of your renewal. You must ensure that any information provided on the Membership Form used to calculate your fee is accurate, and you update us of any changes to that information which mean a higher Membership fee applies. We reserve the right to charge you backdated fees if we find your Membership fee has been calculated on the basis of incorrect information.

Any increase in Membership fees will be notified to you before your next renewal.

Connect's Membership Year runs from 1 August to 31 July. If we <u>do not</u> receive the Membership Form and payment for the next Membership Year before 31 July, your Membership will expire. If we <u>do</u> receive the Membership Form and payment for the next Membership Year in that time, your Membership will be renewed for the next Membership Year. The Membership Form and payment may be submitted on paper or electronically.

If your Membership expires, you will no longer be covered by the Membership-linked Insurance (if applicable) unless, and until, your Membership is reactivated, and any rights associated with your Membership will terminate.

Your Membership will only be reactivated when we receive a Membership Form and payment for the next Membership Year.

At our discretion, we will provide a partial refund of Parent Council/PTA and Club/Organisation memberships when we are informed by the Key Contact that the group wishes to cancel membership during the membership period. The refund will be calculated based on when during the membership year the request is received and will be subject to an administration fee of £10. Please contact info@connect.scot for more details.

Individual Memberships are non-refundable.

We accept payment by bank transfer or cheque. We do not accept cash.

We can provide a discount for new Members who join part way through the Membership Year: 15% for those joining between November and January, 30% between February and April, and 50% between May and July. **This is only for new Parent Council/PTA and Clubs/Organisations Members**. This does not include Individual Members.

It is your group's responsibility to inform Connect of significant changes in the school's pupil numbers which could alter your annual membership fee. Connect reserves the right to consult local authority databases, your school or other reliable sources to verify school pupil numbers to determine your group's appropriate annual membership fee.

Where it is identified that the group is underpaying its Membership fee, we will get in touch with the Key Contact by email. You agree to pay the difference in Membership level fees within 28 days of Connect notifying you. Failure to pay the additional fee may result in the cancellation of your Connect Membership. You have the right to appeal to our Membership team where you feel a mistake has been made within 28 days of receiving the Connect Membership fee notification.

We may terminate this Agreement, or we may suspend your Membership, with immediate effect by giving written notice if you commit a material breach of any term of this Agreement and (if such a breach is capable of being remedied) you fail to remedy that breach within 10 working days of being notified in writing to do so.

On termination of this Agreement for any reason, your Membership (as well as your cover under the Membership-linked Insurance, and any rights to use or enjoy Benefits, including access to the Members' Only resources on our website) will automatically terminate. Our and your liabilities as at termination shall be unaffected, and clauses which expressly or by implication survive termination shall continue in full force and effect.
